**REGIONAL WIND LOAD EXPOSURE CATEGORY FOR
FENCES PROCEDURE - UPDATE**

This advisory is to inform you that SNBO has decided to withdraw the subject procedure. The following conditions will be utilized in accomplishing this withdrawal:

1. The subject procedure will no longer be accepted for projects designed to the 2012 International Building Code.
2. Any permitted and inspected walls may continue the construction activities through completion under the original design assumptions.
3. Free-standing fence walls 6'-0" in height or less and 6'-0" in height or less fence walls atop retaining walls not exceeding 7'-4" in retaining height may be designed to full stresses without requiring special inspections.
